Skin contact:	act: Remove all contaminated clothes and footwear immediately unless stuck to skin.

4.3. Indication of any immediate medical attention and special treatment needed

Turn leaking containers leak-side up to prevent the escape of liquid.

Environmental precautions: Do not discharge into drains or rivers. Contain the spillage using bunding.
